(i)	Based on the performance in the Computer Based Test (CBT) conducted from 15.12.2020 to 18.12.2020, Stenography Skill Test (for Stenographer/English) held on 29.10.2021 & Translation Test (for Jr.Translator/Hindi) on 30.10.2021 and Documentary Verification cum Medical Examination from 23.05.2022 to 25.05.2022 for various posts of Ministerial & Isolated Categories under CEN No. 03/2019 and options furnished in online applications, Candidates bearing the following roll numbers arranged in ascending order (not in order of merit) have been provisionally shortlisted for Provisional Panels.	
(ii)	There are some candidates who have not been allowed in Medical Examination in want of certain documents/clarification. The result of these candidates is being withheld.	
(iii)	The results has been prepared based on the principles/process laid down in Para 13.0 of detailed CEN.	
(iv)	In case of two or more candidates securing same marks, their merit position has been determined by age criteria. Older person has been placed at higher merit and in case age being same, then alphabetical order (A to Z) of the name has been taken into account to break the tie.	
(v)	For remaining vacancy of Category No. 5 and 7, list of candidates for Re-Document Verification cum Medical Examination will be Published later on.	
(vi)	Candidature of all the candidates appearing in these provisional panels is purely provisional and is liable to be cancelled in case of any inconsistency/deficiency of the data furnished by them in the online application or any mal-practice on the part of candidate coming to the notice of RRB during or after appointment/recruitment process. It may be noted that merely getting placed in the Panels does not entitle them in any way to an appointment in the Railways.
