List of Candidates shortlisted for Document Verification and Medical Exam for various posts in Pay Level 5

- (1) Candidates bearing the Roll Numbers listed herein under have been provisionally shortlisted for the Document Verification (DV) for the posts notified in Pay Level 5, based on their score in 2nd stage CBT, qualifying status in Typing Skill Test (wherever applicable) and the priority for various posts in Pay level 5 furnished by them in the online application. The candidates called for DV for Pay level-6 but could not be empanelled in Pay level-6, due to reasons like being absent, lower medical fitness etc., are also considered for posts in Level 5 based on their merit and according to their medical fitness, as per Sl. No. 6 of Notice on Document Verification process dated 14.09.2022.
- (2) **The Document Verification (DV) will commence from 28.11.2022 onwards**, the details will be published in the website. The candidates scheduled for DV will get an email and SMS to download their e-call letter from RRB Website.
- (3) **Candidates may note that after successful completion of DV, they have to undergo Medical Examination at the nominated Railway Hospitals located in the jurisdiction of RRB.** The candidates are required to come prepared to stay for three to four days. Candidates have to pay the prescribed medical fee of Rs.24/-. **Accordingly, candidates have to come prepared for DV and medical examination.**
- (4) The shortlisted candidates for DV should produce all the original documents along with two sets of Xerox copies in A4 size paper as detailed in the CEN and e-call letter.
- (5) Candidature of all the shortlisted candidates for Document Verification is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency / deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRB at any stage of the recruitment process. It may be noted that merely calling a candidate for Document Verification does not entitle him/her in any way to an appointment in the Railways.
- (6) Additional candidates may be called for 2nd round of DV to fill up the shortfall, if any, as and when necessary.
- (7) While every care has been taken in preparing the list of candidates shortlisted for Document Verification, RRB reserves the right to rectify any inadvertent error or typographical or printing mistake. RRB regrets for inability to entertain any correspondence with unsuccessful candidates.
- (8) Important: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerised and the selection is purely based on the merit of the candidates.
- (9) **Candidates are advised to visit RRB's official website regularly for the updates.**
- (10) The Roll Numbers of provisionally shortlisted candidates for Document Verification are arranged horizontally in ascending order and not in the order of merit.
