Notice regarding option of appeal for medically unfit candidates after DV

After being shortlisted for Document Verification for various posts of Junior Engineer in Level-6, the following candidates appeared for Document Verification in the office of Chairman, Railway Recruitment Board, Bhubaneswar which was followed by the medical examination at various Railway Hospitals.

However, as per the medical reports received from the Railway Hospitals, the following candidates were found **unfit** in prescribed medical standard (A3):

As per the instructions contained in Railway Board's letter No.2014/H/5/8/(Policy), Dated: 07/07/2017, the candidates may submit their appeal against the decision of the Railway Medical Committee.

The procedure of appeal is as follows:

(i) If any candidate wishes to appeal against the decision of the medical committee, he/she should submit his/her appeal to the Principal Chief Medical Director of East Coast Railway within the period of one month from the date of issue of this notice with due justification. The appeal so addressed to the *Principal Chief Medical Director, East Coast Railway, Bhubaneswar* should reach at the following address by Speed Post or delivered by hand on any working day:

The Member Secretary, Railway Recruitment Board, D-79/80, Rail Vihar, Chandrasekharpur, Bhubaneswar, Odisha, PIN -751023.

(ii) Such an appeal shall be entertained, only if the candidate produces a medical certificate from a Government/Private doctor of the Speciality/Specialities in which the candidate has been found Unfit. Such certificate should contain a note that "The Government/Private Specialist is fully aware of the physical and visual standards set by the Railways for the particular medical category and that he/she is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate medical board comprising of three Senior Railway Doctors appointed by the Government in this regard".

(iii) The certificate should bear the photograph and marks of identifications of the candidate duly attested by such a Government/Private issuing authority. Such an issuing authority shall also clearly mention his/her full name, designation, address etc. and his/her Medical Council of India/State registration number.

So, if any candidate wishes to appeal against the decision of the medical committee concerned, he/she should submit an appeal for medical re-examination, as indicated above, to Railway Recruitment Board, Bhubaneswar by **24-01-2026** with the following three documents:

- a) Appeal for medical re-examination with justifications duly signed by the candidate indicating his/her Roll No., Registration No. and date of Document Verification. (Annexure-B)
- b) Medical certificate issued by Government/Private Specialist Doctor as per the format enclosed as **Annexure-A.**
- c) A Demand Draft for Rs.1000/- (Rupees one thousand only) in favour of PFA, East Coast Railway, Bhubaneswar.
